Our morning began with karanga, mihi, waiata, and karakia to the whenua. It was a beautiful daythe sun was shining, and as the karanga resonated, the tūī were singing.

We wish to express our appreciation to Ngāi Tahu. Despite longstanding concerns within our iwi regarding ownership, we recognise Ngāi

Tahu's role as responsible kaitiaki until we were in a position to return the whenua to Whakaue ownership.

The Te Kohea Ltd Board (David Tapsell, Malcolm Short and Tupara Morrison) have commissioned a report from Ben Manley to document the history and whakapapa of Te Kohea. After more than 100 years of use as a farm and tourist attraction, for now the whenua simply rests. We look forward to receiving and sharing further updates as these come to hand.

# From the Chair

### Tēnā koutou e te iwi

#### Relationships - Ngāti Whakaue ki Maketū

Ngāti Whakaue ki Uta - Ngāti Whakaue ki Tai relationship can be described as an historical practice of how our tūpuna organised themselves in terms of 'knowing' social, economic and cultual practices, benefits and opportunities 'at place' - ki uta/ki tai - and the practice of reciprocity. To uphold this legacy there must be a willingness and generosity of spirit to communicate and engage.

#### Re-mandate

I am heartened to advise progress has been made with our Ngāti Whakaue ki Maketū whanau in terms of rebuilding a level of trust and confidence so that we can move forward to advertise the refreshed mandate hui. Our Operations team are currently working on the logistics; organizing venues, advertisement notice, confirming independent observer, facilitator etc.

Te Arawhiti accepted the locations proposed to hold these hui in Auckland, Hamilton, Rotorua and Maketū. The hui in Rotorua will be livestreamed to enable Ngāti Whakaue members unable to attend one of the advertised locations and who live elsewhere in NZ can participate.

The hui are likely to take place last week in July, so keep an eye out for the advertisements and on the Ngāti Whakaue Journey to Settlement Facebook page and other Ngāti Whakaue social media platforms.

We are confident there will be broad support for Te Komiti Nui's refreshed mandate.

#### **Preparing for Negotiations**

Te Komiti Nui's overarching principle to settlement negotiations is inclusivity and are committed to accommodating arrangements for claimants to have meaningful participation and input into the proposed work streams; ie Historical Account, Identify key redress items for negotiation, Cultural redress, Commercial redress/deferred purchase &/or Right of first Refusal, Post Settlement Governance Entity (PSGE) and ensuring as many as Ngāti Whakaue people are registered.

These are significant pieces of work that forms the basis of our approach and aspirations for settlement including to calculate loss of income from lands that were taken by various means and acts of the Crown.

Our analysis of each of the Claims still to be settled is predominantly land loss and access to and management of Ngāti Whakaue natural resources taken by various legislations.

#### **Koeke Interviews**

To date we have completed 19 interviews capturing the voices of our people – growing up as Ngāti Whakaue, their connection to place and tupuna, what is was like, who and how they influenced you growing up – moving into more reflective recall on what were you told or learned on how and what the town was like in the 1840s and their understanding of the full extent of Ngāti Whakaue's tribal estate and how much is still in Ngāti Whakaue ownership.

Pukeroa Oruawhata Trust has announced its long-standing Chair, Malcolm Short, will retire at this year's trustee election.

To ensure a smooth leadership transition, David Tapsell has been unanimously elected by the trustees as Chair and Tina Ngatai Deputy Chair of the Pukeroa Oruawhata Trust and group of companies, effective from 15th February 2024. The Trustees acknowledge the significant contribution that Mr Short has made to the Trust including during his time as Chair since 1984. Trustees also offered a new role for Mr Short

as Patron of the Trust given his unique contribution and standing. Following a period of rapid growth over a number of decades, the Trust will now move to a new phase of consolidation, including debt management, with a strong focus on optimising its current holdings, operations and governance.

New projects and opportunities will only be considered in light of this approach and non-debt investment options. The trustees note that Pukeroa is not immune from the tighter global and national economic outlook, and they will adapt its operations and asset management accordingly.

Pukeroa is comitted to collaborating closely with other Ngāti Whakaue entities alongside continuing and accelerating dialogue with the Crown and Rotorua Lakes Council to fully complete outstandig matters from the 1993 Settlement.

The trustees look forward to continuing the Pukeroa legacy for the benefit of our owners and current and future generations of Ngāti Whakaue.
