I want to congratulate Te Roro-o- te Rangi, Ōwhata Marae, for hosting Whakaue Whakanuia 2024 and acknowledge all our marae/hapū for participating and demonstrating the spirit of whanaungatanga. Can I just say how proud I am of my Te Kuirau whānau who took out top spot, although I must admit, Te Koutu marae, what a tribute to 'back in the day' of Tama dances and the Tai Paul band – very innovative. Ngāti Whakauetanga is alive and well.

#### Te Komiti Nui Updates

 As at the 23 November 2024, date of TKN AGM, we had still not received notice from the Ministry for Treaty Negotiations of his (and other relevant Ministers) endorsement or not of the fresh Deed of Mandate.

> The delay by the Minister for Treaty Negotiations is not helpful for our Claimants or Ngāti Whakaue katoa and TKN is held accountable by our iwi for the delays. Despite that TKN is just getting on with facilitating all the elements for an inclusive approach to these historical negotiations.

The Board and the operations team are conscious that claimants must be conversant with the proposed approach to the negotiations.

Everyone has a role to play as we prepare to engage with the Crown.

'As set out in each of the Statement of Claims whānau/ hapū o Ngāti Whakaue have been and remain prejudicially affected by the Ordinances, (decrees, orders, rules etc) Acts, Regulations,(laws, policies, practices, acts and omissions [oversights, errors, inadvertences]) of the Crown, which were enacted, promulgated, formulated, undertaken, done or omitted to be done by the Crown in breach of the principles of the Treaty of Waitangi'.

'To pave our way for the future, we must first resolve our past and the restoration of Ngāti Whakaue mana'.

2. Given the volume of reforms this coalition government is accelerating through parliament appears to have detrimental impacts on the gains lwi have made over the past decade or so is not helpful for Ngāti Whakaue as we navigate and attempt to understand the impacts these reforms may have on our negotiations.

Your Resource Management Unit/RMU team are working diligently to respond through the submission process and where necessary be inclusive of the marae/hapū where their interests may be affected. I would like to take this opportunity to wish everyone a safe festive season.

## Whakarewarewa Arbitration

At the recent AGM, it was reported that the Arbitrators' decision was disappointing and that we are considering our legal options.

The decision does not change our ownership in Te Puia NZMACI.

## Collaboration Update Cultural Fund

The Ngāti Whakaue entities have agreed to centralise and contribute annually to a 'Cultural Fund' to support initiatives and programmes that uphold and promote cultural practices and values of Ngāti Whakaue. This includes encouraging participation especially amongst rangatahi; and to support the meeting of cultural responsibilities of NW koeke and paepae. A centralised fund will make the distribution of grants for such kaupapa easier and more streamlined as each NW entity will have an entity representative as well as one koeke rep and one rangatahi rep considering the applications. It will mean only one application will be required rather than separate applications to the various entities. This collaborative project is still being developed, but we hope to announce the process and make available application forms in 2025.

## Te Ahu o Te Reo

Te Taumata o Ngāti Whakaue has proudly delivered Te Ahu o te reo Māori, an education initiative that aimed to support early learning to secondary school leaders, kaiako and support staff to grow their capability and confidence in using and integrating Te Reo Māori into the learning of all ākonga.

Te Ahu o te reo Māori was launched nationwide in 2021 and was designed to upskill 40,000 teachers and school staff by 2024.

Te Taumata o Ngāti Whakaue engaged more than 1000 ākonga from ECE, Primary and Secondary schools, Kōhanga Reo and Kura across the Te Arawa waka boundary from Maketū, Te Puke, and Ōtamarākau, through to Rotorua, Taupō and Tūrangi. We celebrated the graduation of 133 ākonga from the seventh and final intake of our bespoke programme, Te Pūāhuru, culminating 650 graduates in total across our cohorts.

To all who have engaged in and contributed to the successful delivery of Te Ahu o te reo Māori ki te rohe o Te Arawa waka, especially our pouako, pūkenga, pūkōrero and paepae – E kore e piroku noa te hatete o mihi, e whitawhita nei.
